Competitive Events — 15 K Run, 5 Mile Run and 2 Mile Youth Run Non-Competitive Events — 5 Mile Walk, 2 Mile Fun Run/Walk, 15K Bike

15K Run and Bike travel through Fumee Lake Natural Area. The course is mostly flat, unpaved scenic trails. The 5 Mile and 2 Mile events are around beautiful Lake Antoine. The course is flat and paved (will accommodate strollers). Leashed dogs are welcome.

All pre-registrants receive a t-shirt. Race day registrants receive shirts as long as supplies last. Race is sanctioned by the Upper Peninsula Road Runners Club and every effort is made to assure the safety of all participants. Water and aid stations are located throughout the courses and beverages/refreshments are provided at the finish. Proceeds benefit local area Special Olympics.

AWARDS: 15K and 5M = Awards to top 3 M/F overall, medals to top 3 M/F each age division

2M Youth = Medals to top 3 M/F each age division.
